#### **Parent Volunteers Are Required For All Swimmers**

Did you realize that it takes at least 26 parents to put on a home A meet??

Swim teams, unlike most sports, require parent volunteers *during* all swim meets. Without these volunteers, meets would not be possible. The Woodlands Country Club swim team can only function if swim team parents volunteer support and time. If your child is on the team, we expect you to become involved. Signup sheets will be available at registration and through email – all families are expected to volunteer for at least 3 positions during the season. If you do not sign up in advance, you will be assigned a task and it will be your responsibility to find a substitute if you are unable to participate at the assigned time.

#### Duties include:

**Officiate A meets (3 for home, 2 away)-** Must be trained through CSL as an official. Responsible for insuring all stroke and turn rules are followed by swimmers.

**Head Timer (1)-** Maintains extra stop watches for each race.

**Timers (12 home, 6 away)-** Maintains a stop watch and records time for all swimmers in an assigned lane.

**Announcer/Starter** (1)- Must be trained through CSL. Responsible for starting all races.

Ribbons (2 home, 1 away)- Responsible for handing out ribbons to swimmers as they finish.

Clerk of course (3 – see note below)- Responsible for insuring all 10U swimmers are lined up behind the appropriate blocks for each race.

Scoring (2 home, 1 away)- Responsible for scoring the meet. Software training required through CSL.

Runner (1)- Responsible for duties on deck as needed.

**Hospitality** (1)- Responsible for passing out water to all volunteers on deck.

Clerk of course responsibilities will be for the 10 and under swimmers only. Parents of 10u swimmers will be **required** to clerk for one A meet unless they are serving in a different head capacity (i.e. head timer, scorer, etc).
